A photographer needs to be emotionally involved in an image so that we, the viewer, might be. This is often aided by economy in composition. Images should be cropped in the viewfinder or on the desktop with a .sharp blade.. Elements should move the eye effortlessly around a piece-by the elements of content, color, texture, or light. Miscues in focus or in printing weaken the impact from all aspects. Lastly, Bill thanks the members for their desires and commitment to create, grow, and leave a visual legacy of their time.
